

# Summary of Our Attendance Policy

- At Astley CE Primary school, we expect all children to attend school every day.
- We understand that this may not be possible if the child is ill. If your child is too ill to attend school, we expect a <u>parent</u> <u>or legal guardian</u> to contact the school before 9am and give a reason for the absence on <u>each day</u> of the absence.
- We have a duty of care for safeguarding your child and we will contact you if we have not been provided with an adequate reason for your child's absence.

#### INFORMATION FOR PARENTS AND CARERS



#### What the Law says

As a parent, you have a <u>legal responsibility</u> to ensure your child is in school every day. Permitting your child to be absent from school without **good reason** is an offence and may result in referral to the Education Welfare Service. This can lead to the issue of Penalty Notices and in some circumstances, prosecution.

### What the Government says

New government guidelines state that attendance figures of 90% or below should be classed as **'persistence absence'**.

They expect that in order to reach a child' full potential, they must attend school for a minimum of 95% of the year.

At Astley, we will inform you each term of your child's attendance. If we feel that their attendance needs to improve, we will arrange a meeting to discuss this and see how we can help

#### Leave of Absence

The Department for Education has clear guidelines regarding Leave of absence during term-time.

Leave of absence during Term-time in not permitted unless it is for

**exceptional circumstances**. Schools have clear instructions not to authorise leave unless these exceptional circumstances are met.

Family holidays will very rarely be considered as exceptional circumstances. Our Attendance Policy has more detail on this.



- \* Children with attendance between 95% and 100% have the greatest potential to achieve their best, educationally and socially.
- 90% attendance may sound quite good, but....

90% = half a day missed each week of the school year (123 hours of learning)

90% = 1 month off school each school year 90% = 1 whole school year missed of your child's statutory education

#### Attendance Ladder

Equates to number of school days off each year	100%	> Perfection
4 School days missed	<b>98%</b>	Impressive
6 School days missed	97%	Good
<b>7</b> School days missed	96%	On Target
9 School days missed	<b>95</b> %	Slight Concern
School days missed	93%	Concerns
20 School days missed	<b>90</b> %	Very Concerned
30 School days missed	85%	Serious Concerns

## **Illness Guidance**

Being ill may prevent your child from coming to school, however, if they are well enough to play at home or enjoy watching TV, then they should be in school.

Coughs and sneezes or feeling tired are not reasons to miss school and can be managed by staff at school.

Your child's welfare is very important to us and we will of course contact you if we feel they are too poorly to be at school.

### **Unauthorised Absence**

#### What does this really mean?

Significant unauthorised absence percentages can result in a fixed penalty notice being issued by the Local Authority.

As a maintained school our attendance is monitored by the Local Authority and Department for Education automatically.
